Any vehicle displaying a hang tag that has been reported missing/stolen are subject to immediate tow and the theft of the tag will be reported to the local police department. I have read in full and understand that it is my responsibility to comply with all of the community parking rules & regulations. It is also my responsibility as a resident of this community to inform and assure that guest/visitors to my residence comply with said rules. I understand that failure to comply with these rules may result in suspension of parking privileges, issuance of a notice of parking violation and/or impound of my vehicle(s) consistent with 22658(a) CVC. I acknowledge if I fail to pay any and all fees it may result in impound of my vehicle. I also understand that if my vehicle is towed as a result of incorrect or invalid information or I transfer the issued permit to another vehicle, I accept full financial responsibility for all fees incurred. I further understand that the issuance of an "Unassigned" permit does not guarantee my vehicle a parking space. I understand that all parking is on a first come, first serve basis.
